#### Composition:

Active substances and their concentration: 20% Oxide Zinc

Use the preparation correctly. Consult your pharmacist if you require additional information. If there is no improvement in your condition within a week, consult your physician.

### 1. What the medicine is used for ?

The medicine is indicated for relief of various skin irritations.

Therapeutic Group - Topical anesthetic for treatment of itching.

#### 2. Before using the medicine

## X Do not use the preparation:

 If you are sensitive (allergic) to the active substance lodine or to any of the additional ingredients contained in the medicine. For the list of the inactive substances - see Section 6 "Additional information".

#### Special warnings concerning use of the medicine:

- Do not use this medicine frequently, or for a long period, without consulting a physician.
- Avoid contact with the eyes and mucous membranes such as mouth and nose. In case of such contact, rinse thoroughly with water.
- Do not use this medicine on large areas of open skin.

Consult your physician before starting the treatment with Lotio Zinci if you are

· sensitive to any food or medicine

I If you are taking, or recently took, other medicines, including over the counter medicines and dietary supplements, inform your doctor or pharmacist.

## How to use the medicine?

Ask your doctor or pharmacist if you are not sure how to use it.

The generally recommended manner of use: Shake the bottle well before use and apply gently on the affected area of skin. Leave the area to dry.

The generally recommended dosage is a few times a day, as necessary. If there is no improvement in your condition within a week, consult your physician.

### Do not exceed the recommended dosage. Do not swallow. For external use only.

If you have taken an overdose or if a child has accidentally swallowed the medicine, go immediately to a doctor or a hospital emergency room and bring the medicine package with you.

Do not take medicines in the dark! Check the label and the dose each time you take your medicine.

Wear glasses if you need them.

If you have further questions concerning use of the medicine refer to your doctor or pharmacist.

## 4. Side Effects:

As for any medicine, the use of Lotio Zinci may cause side effects in some users. Do not be alarmed by the list of side effects. You will probably not suffer from any of them.

## Stop treatment and refer to your doctor: In the event of local itching, rash or

inflammation (that did not exist before use of this preparation), (rare).

## Side Effects and Drug Interactions in Children and Infants:

Parents must inform the attending physician of any side effect observed in the child. If a side effect appears, if one of the side effects becomes more serious, or you suffer from a side effect not mentioned in the insert, consult your doctor. ### 5. How to store the medicine?

Avoid poisoning!

This medicine, and all other medicine, must be stored in a safe place out of the reach of children and/or infants, in order to avoid poisoning.

Do not induce vomiting unless explicitly instructed to do so by the doctor.

Do not use the medicine after the expiry data appearing on the package.

date appearing on the package.
The expiry date refers to the last day of that month.

Store in a cool place, below 25°C. Close tightly to prevent entry of air

and damp.

• Store in the original package.

• You can use the product after opening until its expiry date.

#### 6. Additional information

the medicine also contains: Purified water, Talc, Glycerin, Bentonite, Sodium citrate, Liquefied phenol.
