Patient package insert in accordance with the Pharmacists' Regulations (Preparations) 1986.

No doctor's prescription is needed for this medicine.

The format of this bulletin was determined by the Ministry of Health who has reviewed and approved its content.

Active Ingredients: Povidone Iodine 10%, Ethanol 65%.

Read this leaflet carefully in its entirety before using this medicine. This leaflet contains essential information about the medicine. If you have additional questions, consult your doctor or a pharmacist.

You must use this medicine in a proper manner:

- Consult your pharmacist if you need additional information.
- Inform your doctor if the disease's symptoms worsen or will not get better after a few days use.

1. Therapeutic Activity:

For Antiseptic treatment of skin.

Therapeutic Group: Antiseptic substances (disinfectants).

2. Before using the medicine:

Do not use the medicine if:

you are sensitive (allergic) to one of the ingredients of the medicine or to Iodine. If you suffer/ed from a malfunction of the Thyroid gland, do not use the medicine before consulting a doctor .

If you are sensitive to a particular food or medicine, you should report this fact to your doctor before commencing treatment with this medicine.

Special warnings concerning the use of the medicine:

- If you are taking another drug concomitantly or if you have just finished treatment with another medicine, including non prescription medicines or food supplements, inform the doctor or the pharmacist in order to prevent hazards or lack of efficacy arising from drug interactions.
- The alcohol in this product will cause stinging on contact with open wounds. This product is primarily designed for pre-operative use and disinfection prior to injections and not for disinfection of open wounds.

• Pregnancy and breastfeeding:

If you are pregnant or breastfeeding, consult a doctor or a pharmacist before you begin using the medicine.

3. How to use the medicine?

Consult your doctor or pharmacist if you have any doubts.
Attention: Do not swallow! This medicine is intended for external use only.

Directions for use: Apply on your skin by using cotton of gauze pad.

Do not take this medicine in the dark! Check the label and dose **each time** you use your medicine. Wear glasses if you need them.

4. Side Effects:

- Like in other drugs, using Polydine Tincture may cause some side effects to appear for some of the users. No need to be alarmed while reading the side effects list. You probably will not suffer from any of them.
- In addition to the desirable impact of the medicine, there might be some side effects like a rash.
- **Side effects that demand special attention:** irritation and swelling.

5. How to store the medicine?

- **Avoid Poisoning!** This medicine like all other medicines, must be stored in a safe place and out of the reach of children and/or infants, to avoid poisoning. If a child has accidentally swallowed the medicine, proceed immediately to a hospital emergency room and bring the package of the medicine with you. **Do not induce vomiting** unless explicitly instructed to do so by a doctor!
- Do not use the medicine after the expiry date printed on the package. The expiry date is always the last day of that month.
- Do not store over 25°C.
- Always keep in the original package.
- Shelf life after opening is until the expiry date.

- How does the medicine look like and what are the contents of the bottle? A brown colour liquid with an alcoholic scent, in a 1 liter bottle.
