1. WHAT IS THE MEDICINE INTENDED FOR? First aid antiseptic for external use in minor in injuries, wounds and burns.

Therapeutic group:

Antiseptics

Chlorhexidine is an antiseptic with a broad spectrum of activity against microorganisms including bacteria, fungi and viruses.

Cetrimide has antiseptic characteristics.

BEFORE USING THE MEDICINE

Do not use the medicine if:

- Do not use the medicine it:

 Do not use this medicine if you have known sensitivity to any of the ingredients of the medicine, especially to chlorhexidine, which could cause an allergic reaction, or to cetostearyl alcohol, which could cause a local skin reaction. Do not use this preparation in the mouth and eye area.
- Do not use the preparation in the middle ear.

Special warnings regarding use of Savior:

- If you are sensitive to any food or medicine, inform the doctor of this before using the medicine.

 Do not use this preparation frequently or for a long period without consulting a doctor.
- In cases in which swelling develops in the wound, or the wound is accompanied by fever, consult a doctor.

Drug interactions:

If you are taking, or have recently taken, other medicines including non-prescription medicines and nutritional supplements, tell the doctor or pharmacist.

Avoid using soap and other anionic agents together with Savior since bleaches, containing hypochloride, may cause brown stains to appear on fabrics that have previously been in contact with Savior.

Pregnancy and breastfeeding:

If you are pregnant or breastfeeding, think you are pregnant or are planning to become pregnant, consult the doctor or pharmacist before use.

After using Savior in the chest area, it is recommended to wash the area thoroughly with water before breastfeeding.

Important information about some of the ingredients of the medicine:

The medicine contains cetostearyl alcohol, which could cause a local allergic reaction in the skin (e.g., contact dermatitis).

3. HOW SHOULD YOU USE THE MEDICINE?

Check with the doctor or pharmacist if you are uncertain regarding the dosage and treatment regimen of the regarding preparation.

Directions for use:

For external use only. Do not swallow! Wash hands thoroughly before and after use.

Spread the cream in a thin layer on the affected area.

Avoid contact of the medicine with the eyes. In case of contact with the eyes, rinse them well with water.

If there is no improvement in your condition within several days, refer to a doctor.

If you took an overdose or if a child has accidentally swallowed the medicine, refer immediately to a doctor or proceed to a hospital emergency room, and bring the package of the medicine with you.

Do not use the medicine in the dark! Check the label and the dose <u>each time</u> you take medicine. Wear glasses if you need them.

As with any medicine, use of Savior may cause side effects in some users. Do not be alarmed when reading the list of side effects. You may not suffer from any of them.

Stop using the medicine and refer to the doctor immediately if:
You experience any of the following rare allergic reactions: breathing difficulties, swelling of the face, tongue or throat, dizziness, skin irritation or rash.

If a side effect occurs, if one of the side effec worsens or if you suffer from a side effect n mentioned in the leaflet, consult with the doctor.

 Avoid poisoning! This medicine, and any other medicine, should be kept in a safe place out of the reach and sight of children and/or infants in order to avoid poisoning. Do not induce vomiting unless explicitly instructed to do so by a doctor.

 Do not use the medicine after the expiry date (exp. date) that appears on the package. The expiry date refers to the last day of that month.
- Storage conditions: Store this medicine below 25°C.
- Savior Cream can be used for up to 12 months after first opening the tube, but not later than the expiry date of the medicine. Savior
