Active ingredient

Each vaginal tablet contains:

clotrimazole 200 mg

What is this medicine intended for?

Clothree is an antifungal medicine for treating infections in the vagina and external genital organs, in women, caused by the following infectious agents: Candida albicans and trichomonas

Vaginal inflammation caused by trichomonas requires combined treatment with Clothree and oral metronidazole

Therapeutic group: antifungals from the azole family.

Vaginal thrush is a common infection from which most of the women suffer at a certain stage of life and is not caused by impaired personal hygiene. Vaginal thrush is caused by a fungus called Candida, residing in the vagina and various organs without causing any damage and unnoticed by you. However, the natural balance that keeps Candida under control can be affected by several factors, such as hormonal changes (menstrual period, contraceptive pills, pregnancy, menopause), poor health, intake of antibiotics, fragranced soaps, bath additives and tight clothes.

Change in the natural acidity (pH) may lead to increased growth of the fungus, which may then develop into an infection.

This can result in the following symptoms: persistent sensation of burning and/or itching around the vagina and vulva, redness, swelling and pain in the vaginal and vulvar tissues and white odorless vaginal discharge. You may not experience all of the symptoms listed above, but only one of them.

2. Before using this medicine:

Do not use this medicine if:

You are sensitive (allergic) to the active ingredient (clotrimazole) or to any of the other ingredients that this medicine contains (see section 6 'Additional information')

Special warnings regarding use of this medicine Use the medicine only if your doctor has previously diagnosed you with vaginal thrush.

Before treatment with Clothree, tell your doctor if: • You are not sure whether you have a vaginal thrush, or if this is

- the first time you have experienced these symptoms
- You have had more than two vaginal thrush infections in the last 6 months
- You or your partner has ever suffered from a sexually transmitted
- You are below the age of 16 years or over the age of 60 years.
 You have ever experienced an allergic reaction to Clothree or to
- other vaginal antifungal medicines. • If you have any of the following symptoms, Clothree may not be
- a suitable treatment for you:
- o irregular vaginal bleeding
- o unusual vaginal bleeding or bloody discharge
- ulcers, blisters or sores in the vagina or vulva
- o lower abdominal pain o pain or difficulty in passing urine
- fever or chills
- o nausea or vomiting
- diarrhea
- vaginal discharge with a bad odor
- Like other medicines for vaginal use, Clothree may reduce the effectiveness of contraceptives made of rubber, such as a condom and diaphragm. Therefore, you should use alternative contraceptives for at least 5 days after treatment with the • Do not use tampons, vaginal douching preparations, spermicides
- or other vaginal preparations during treatment with this medicine. • Refrain from vaginal sexual intercourse while you have a vaginal
- thrush and during use of Clothree, because your partner could become infected. Girls and adolescents

Clothree vaginal tablets are intended for use in women, and in girls and adolescents aged 12 years and up.

Drug interactions

If you are taking or have recently taken other medicines, including non-prescription medicines and dietary supplements, tell your doctor or pharmacist.

Especially inform the doctor or pharmacist if you are taking tacrolimus or sirolimus (intended to reduce the immune system response to prevent transplant rejection after organ transplantation). Pregnancy, breastfeeding and fertility

Pregnancy

If you are pregnant, breastfeeding, or trying to become pregnant, consult your doctor or pharmacist before using Clothree and follow their instructions carefully. Clotrimazole may be used during pregnancy only under a doctor's supervision. Do not use the insertion device throughout the pregnancy period.

Breastfeeding

There are no data regarding passage of the medicine into breast milk. Absorption into the circulation after use of the medicine is minimal, therefore it is unlikely to cause systemic effects. The medicine can be used during breastfeeding.

Fertility No studies on the effect of the medicine on human fertility have been conducted. However, animal studies have demonstrated no

effect on fertility. Driving and using machines:

This medicine has no effect or a negligible effect on the ability to drive or operate machines

3. How to use this medicine?

Check with your doctor or pharmacist if you are not sure about your

dose or about how to use this medicine.

The recommended dosage is usually: One tablet for vaginal insertion in the evening before bedtime, for 3 consecutive evenings (see 'How to use the medicine - general

- Do not exceed the recommended dose Treatment duration: • The symptoms of candidiasis should resolve within 3 days of treatment initiation. If your condition does not improve within 7
- days, contact your doctor. • If candidiasis recurs after 7 days, you can use an additional treatment, but if you suffer from candidiasis more than twice within 6 months, contact your doctor.

Mode of administration: • For vaginal use only. Do not put in your mouth or swallow. If you have accidentally taken an overdose, accidentally swallowed the tablet, or if a child has accidentally swallowed some medicine, immediately see a doctor or go to a hospital emergency room and bring the medicine package with you.

How to use the medicine – general instructions: If Clothree has been prescribed to you by your doctor, follow their

If you have purchased the medicine without a doctor's prescription, use the medicine as described in this section.

- The applicator enclosed with the medicine is intended to assist in inserting the tablet as deep as possible into the vagina, preferably before bedtime for three consecutive evenings.
- The applicator is personal (do not transfer it to another patient) and is intended for use during one treatment period of 3 days
- For hygiene maintenance, before each applicator use, wash its parts separately with water and soap.
- Wash your hands with soap and hot water before removing the
- tablet from the package, and again after using the special applicator.
- If you are pregnant, do not use the applicator to insert the
- Remove the applicator from the packaging. Pull out the inner part of the device (figure 1:a) until it stops. Remove the tablet from the foil packaging and place it in the wide part of the applicator (figure 1:b).
- 2. Insert the applicator containing the tablet as deep into the vagina as possible, without causing discomfort (The best way to do it is lying on your back with legs bent and knees pointing upward). Hold the applicator in place and push the plunger slowly until it stops, so that the tablet is inserted into the vagina (see figure 2).

Pull the inner part of the applicator (a) outwards until it stops. Insert one vaginal tablet into the wide part of the applicator (b)

- 3. Remove the applicator. Wait a few minutes before getting up. After each use, completely remove the plunger (A) from the applicator (B). Wash with hot (not boiling) water and soap and dry carefully. 4. After the end of the treatment period, discard the applicator in
- a safe place, out of the reach of children. Do not discard the applicator in the toilet.
- The vaginal tablet dissolves in the vagina. It is advisable to use a panty liner (pad) since white residues can be frequently observed after using the medicine. This does not indicate that the treatment has not worked adequately. But if you notice whole undissolved pieces of the tablet, the treatment may have been
- unsuccessful, and you should contact your doctor or pharmacist.

 To prevent future recurrence, wear only cotton underwear that is not too tight and change it often. Take a shower every day. Wiping in the toilet should be performed from the front backwards since the fungal infection could be transmitted from the bowel. Refrain from wearing clothes that are too tight and nylon stockings. Refrain from bathing with fragranced soaps or using deodorants in the vaginal area. Do not rub the area firmly with a bath sponge. Refrain from hot baths with strongly perfumed oils.

If you forgot to use this medicine at the scheduled time:

- Use a dose as soon as you remember and continue the rest of your treatment as usual.
- If you forgot for more than one day, the vaginal infection may not have been fully treated. Therefore, if the symptoms persist after the end of the treatment period, contact your doctor.

Do not take medicines in the dark! Check the label and dose every time you take medicine. Wear glasses if you need them.

If you have any further questions about using this medicine, consult your doctor or pharmacist.

Side effects

As with any medicine, using Clothree may cause side effects in some users. Do not be alarmed by this list of side effects; you may not experience any of them.

As with any medicine, some people may be allergic to this product. If you are sensitive (allergic) to the medicine, an allergic reaction will occur soon after using the medicine. Stop the treatment and contact the doctor or proceed to the emergency room at the nearest hospital immediately if you develop an allergic reaction or experience worsening of redness, sensation of burning, pain,

or experience worsening of reuriess, sensation of burning, pain, itching or worsening of swelling.

Signs indicating an allergic reaction include: rash, problems swallowing or breathing; swelling of the lips, face, throat or tongue; weakness, dizziness or fainting; nausea.

Side effects that may occur after using the vaginal tablet:

- itching, rash, swelling, redness, discomfort, burning sensation, irritation, vaginal peeling or vaginal bleeding. pain in the abdomen or in the pelvic region.
- If you experience any side effect, if any side effect gets worse,

or if you experience a side effect not mentioned in this leaflet, consult your doctor or pharmacist. Reporting side effects

- appears on the package. The expiry date refers to the last day of that month. Store below 25°C, do not freeze.
 Do not dispose of any medicine via wastewater or household
