

**PATIENT LEAFLET IN ACCORDANCE WITH THE
PHARMACISTS' REGULATIONS (PREPARATIONS) – 1986**

This medicine is dispensed without a doctor's prescription

Hydrogen Peroxide 3% Life Solution

Composition:

Hydrogen Peroxide 3% w/w

Inactive and allergenic ingredients in the medicine – see section 6 “Additional information”.

Read the entire leaflet carefully before using the medicine.

This leaflet contains concise information about the medicine. If you have any other questions, refer to the doctor or the pharmacist.

Use the medicine according to the instructions in section 3 “How should you use the medicine?” in this leaflet. Consult the pharmacist if you need more information. Refer to the doctor if symptoms of the ailment worsen or do not improve.

1. What is the medicine intended for?

The medicine is intended for disinfection.

Therapeutic class: antiseptic preparations (disinfectants).

2. Before using the medicine

Do not use this medicine:

- If you are sensitive (allergic) to the active ingredient hydrogen peroxide or to any of the other ingredients this medicine contains (see section 6 “Additional information”).
- On healthy skin and in the eyes.
- In closed body cavities and on surgical wounds.
- In an enema.
- For disinfection of surgical instruments.

Special warnings regarding the use of the medicine:

This medicine may bleach fabrics.

Drug interactions:

If you are taking, or have recently taken, other medicines including non-prescription medicines and nutritional supplements, tell the doctor or the pharmacist.

Pregnancy and breastfeeding:

If you are pregnant, may be pregnant or are breastfeeding, consult the doctor before use. Do not use hydrogen peroxide solution during pregnancy or breastfeeding unless instructed by the doctor.

3. How should you use the medicine?

Check with the doctor or pharmacist if you are uncertain.

Do not exceed the recommended dose.

Method of administration:

Do not swallow! This medicine is intended for external use only.

Method of use:

Wipe the area intended for disinfection with a cotton wool ball soaked in the substance.

If you took an overdose or if a child accidentally swallowed this medicine, refer to the doctor or to a hospital emergency room immediately and take the package of the medicine with you.

Do not take medicines in the dark! Check the label and the dose every time you take a medicine.

Wear glasses if you need them.

If you have any other questions regarding the use of the medicine, consult the doctor or the pharmacist.

4. Side effects

As with any medicine, using **Hydrogen Peroxide 3% Life** may cause side effects in some users. Do not be alarmed when reading the list of side effects. You may not experience any of them.

Possible side effects:

Formation of irritating burns on the skin and on soft tissues that turn into white areas of dead tissue. The accompanying pain will disappear after about an hour.

If a side effect occurs, if one of the side effects worsens, or if you suffer from a side effect not mentioned in this leaflet, consult the doctor.

5. How to store the medicine?

- Avoid poisoning! This medicine and any other medicine must be kept in a closed place out of the reach and sight of children and/or infants to avoid poisoning. Do not induce vomiting without an explicit instruction from the doctor.
- Do not use the medicine after the expiry date (exp. date) appearing on the package. The expiry date refers to the last day of that month.

Storage conditions:

- Store in a cool place, at a temperature below 25°C.
- After opening for the first time, the medicine can be used up to the expiry date appearing on the package.

6. Additional information

In addition to the active ingredients the medicine also contains:

Purified Water, Dibasic Sodium Phosphate, Phosphoric Acid
What does the medicine look like and what are the contents of the package?

The medicine is a clear and colorless solution in a 100 ml brown plastic bottle.
