### Composition:

**Active substances and their concentration:**

Calamine 15%, Zinc Oxide 5%

For the list of the inactive substances: See Section 6 "**Additional information**". **Read the leaflet carefully to the end before using the medication.**

This insert contains abridged information on the medicine.

If you have further questions, consult your doctor or pharmacist.

Use the preparation correctly. Consult your pharmacist if you require additional information.

### **1. What Calamine Lotion is used for ?**

The medicine is indicated for relief of various skin irritations

### **Therapeutic Group:**

Topical anesthetic for treatment of itching

### **2. Before using the medicine**

**Do not use the medicine:**

- If you are sensitive (allergic) to the active substance or to any of the additional ingredients contained in the medicine. For the list of the inactive substances - see Section 6 "Additional information".

### **3. Special warnings concerning use of the medicine:**

- Do not use this medicine frequently, or for a long period, without consulting a physician.
- If you are sensitive to any food or medicine, inform your physician before using this medicine.
- Avoid contact with the eyes, mucous membranes. In case of such contact, rinse thoroughly with water.

### **4. Before treatment with Calamine Lotion, tell your doctor:**

- If you are sensitive to any food or medicine.

**5. If you are taking, or recently took, other medicines, including over the counter medicines and dietary supplements, inform your doctor or pharmacist.**

### **Important information about some of the ingredients of the medicine:**

Suspension with a little sediment.

Shake before use.

### **3. How to use the medicine?**

Ask your doctor or pharmacist if you are not sure.

Recommended dosage unless otherwise instructed by the doctor:

Shake the bottle and apply gently on the affected area of skin. Leave the area to dry. You can repeat several times a day as necessary. If there is no improvement in your condition within a week, consult your physician.

### **Do not exceed the recommended dosage.**

**Do not swallow.** For external use only. If you have taken an overdose or if a child has accidentally swallowed the medicine, go immediately to a doctor or a hospital emergency room and bring the medicine package with you.

Do not take medicines in the dark! Check the label and the dose each time you take your medicine.

Wear glasses if you need them.

If you have further questions concerning use of the medicine refer to your doctor or pharmacist.

### **4. Side Effects:**

As for any medicine, the use of Calamine Lotion may cause side effects in some users. Do not be alarmed by the list of side effects. You will probably not suffer from any of them.

### **Stop treatment and refer to your doctor:**

- In the event of itching, rash or local inflammation (that did not exist before use of this preparation), (rare):

Stop the treatment and consult your doctor.

- If one of the side effects becomes more serious, or you suffer from a side effect not mentioned in the insert, consult your doctor. ### **5. How to store the medicine?**

#### **• Avoid poisoning!**

This medicine, and all other medicine, must be stored in a safe place out of the reach of children and/or infants, in order to avoid poisoning.

Do not induce vomiting unless explicitly instructed to do so by the doctor.

- Do not use the medicine after the expiry date appearing on the package.

The expiry date refers to the last day of that month.

- Store in a cool place, below 25°C.

- Close tightly.

- Store in the original package.

- You can use the product after opening until expiry of its validity.

### **6. Additional information**

**In addition to the active substances the medicine also contains:**

Purified water, Glycerin, Bentonite, Sodium citrate, Liquefied phenol.

### **Appearance of the medicine and contents of the package:**

Light pink suspension

Contents: 100 ml
