#### Clopidogrel Teva

This medicine has been prescribed for you. Do not pass it on to others. It may harm them even if it seems to you that their medical condition is similar.

#### 1. What is the medicine intended

The medicine is used for the prevention of atherothrombotic vascular events (heart attacks, cerebral stroke or vascular death) in patients with atherosclerosis who have In patients with atheroscierosis who have had a myocardial infarction or ischemic cerebrovascular event or who have a peripheral arterial disease, and in patients with unstable angina pectoris, including patients undergoing catheterization with stent implantation who are being treated with aspirin

with aspirin.

The medicine is used to prevent atherothrombotic and thromboembolic events (heart attacks, cerebral strokes, embolisms or vascular death) in combination. with aspirin, in patients suffering from atrial fibrillation-type arrhythmia, who are not suitable for treatment with anticoagulants of the vitamin K antagonist type such as warfarin (Coumadin), antithrombin or anti-

Therapeutic class: Platelet aggregation inhibitors, of the thienopyridine group.

## 2. Before using the medicine Do not use this medicine if:

- You are sensitive (allergic) to clopidogrel or to any of the additional ingredients that the medicine contains
- (see section 6). You are suffering from a medical condition which is currently causing bleeding, such as: stomach or bleeding, such as: stomach or duodenal ulcer, bleeding within the brain.
- You have a severe henatic disease If any of these conditions applies to you, or if you have any doubt, consult with the doctor before taking Clopidogrel Teva.

  You have suffered in the past from an allergic reaction or any reaction to any medicine given to you for treatment of your medical condition.

During treatment with the medicine:

You should inform your doctor if surgery has been planned for you (including death.)

  You should also inform the doctor immediately if you develop a medical condition (also known as thrombotic thrombocytopenic purpura or TTP), which includes fever and subcutaneous brusies.
- which includes fever and subcutaneous bruises, which may appear as pinpoint red dots, with or without unexplained extreme fatigue, confusion, yellowing of the skin or eyes (jaundice) (see section 4 "Side effects"). If you injured or cut yourself, it may take longer than usual for the bleeding to stop. This effect is related to the mechanism of action of the medicine, because it prevents the formation of blood clots. In cases of mild cuts or injuries, such as cutting yourself while shaving, there is usually no problem. However, if you are concerned about the bleeding, refer to your doctor immediately (see section to your doctor immediately (see section 4 "Side effects").
  The doctor may ask you to perform

Drug-drug interactions:
If you are taking or have recently taken other medicines including non-prescription medicines and food supplements, tell the doctor or the

pharmacist.
Certain medicines may affect the use of
Clopidogrel Teva, or the other way around.
Especially inform the doctor or pharmacist

- if you are taking:

   Medicines that may increase your risk
  - of bleeding, such as:

    Oral anticoagulants, medicines used to reduce blood clotting.

    Non-steroidal anti-inflammatory
  - drugs (NSAIDs), that are generally used for treatment of pain and/or inflammation of muscles or joints
  - Heparin or any other injectable medicines used to reduce blood coagulation.
  - Ticlopidine, another antiplatelet medicine.

- Selective serotonin reuptake inhibitors (SSRIs) (including, but not limited to, fluoxetine or fluvoxamine), medicines usually used for treatment of depression.
- Rifampicin (used for treatment of severe infections).

  Omeprazole or esomeprazole, medicines
- for treatment of abdominal pain. Fluconazole or voriconazole, medicines for treatment of fungal infections.
- Efavirenz or other antiretroviral medicines (used for treatment of HIV infection).
- Carbamazepine, a medicine for treatment of certain types of epilepsy. Moclobemide, a medicine for treatment
- of depression.
  Repaglinide, a medicine for treatment of diabetes.
- Paclitaxel, a medicine for treatment of
- cancer. Opioids: while you are treated with clopidogrel, you must inform your doctor before being prescribed any opioid medicine (used for treatment of

opioid intedictine (used for treatment of severe pain).

If you have experienced severe chest pain (unstable angina or a heart attack), you may be prescribed Clopidogrel Teva in combination with acetylsalicylic acid, a substance found in many medicines used to reflexe pain and reduce four Castal substance found in many medicines used to relieve pain and reduce fever. Casual use of acetylsalicylic acid (no more than 1,000 mg in any 24-hour period) should generally not cause problems; however, prolonged use in other situations must be discussed with your doctor.

Use of the medicine and food:

The medicine may be taken with or without food.

Pregnancy, breastfeeding and fertility: It is preferable not to take the medicine

during pregnancy. If you are pregnant or suspect that you are pregnant, tell your doctor or pharmacist before taking Clopidogrel Teva. If you become pregnant while taking this medicine, consult with the doctor immediately since it is not recommended to take clopidogrel

during pregnancy.
Do not breastfeed while taking this medicine.

If you are breastfeeding or planning to breastfeed, consult with the doctor before taking the medicine.

Consult with your doctor or pharmacist before taking any medicine. Driving and operating machinery: Clopidogrel Teva is not expected to have any effect on your ability to drive or operate machinery. machinery

Important information about some ingredients of the medicine:

• The medicine contains lactose. If you

- have been told by your doctor that you have an intolerance to certain sugars (such as lactose), contact your doctor before taking this medicine.

  This medicine contains less than 23 mg of sodium in a tablet, and is therefore considered sodium free.
- considered sodium-free.

### 3. How should you use the medicine?

medicine?

Always use the medicine according to the doctor's instructions. Check with the doctor or pharmacist if you are uncertain about the dosage and how to use the medicine. The dosage and treatment regimen will be determined only by the doctor. The usual dosage, including for patients with a condition called "atrial fibrillation" (an irregular heartbeat), is: one tablet of Clopidogrel Teva 75 mg per day, to be taken orally with or without food, and at the same time each day.

If you have experienced severe chest pain (unstable angina or a heart attack), the doctor may instruct you to take a one-time dosage of 300 mg (4 tablets of 75 mg) at the beginning of treatment. Afterwards, the recommended dosage is one Clopidogrel Teva 75 mg tablet once daily taken as Teva 75 mg tablet once daily, taken as described above.

Do not exceed the recommended dose.

You must take Clopidogrel Teva for as long as the doctor prescribes it for you.

Crushing/halving/chewing:
No information is available regarding crushing or pulverizing the tablet.
Do not chew! The medicine should be taken with water. The medicine may be taken

with water. The medicine may be taken with or without food.

If you accidentally took a higher dosage:

Refer immediately to your doctor or proceed to the nearest hospital emergency room, because of the increased risk of bleeding. If you took an overdose or a child accidentally swallowed this medicine, go to the doctor or the emergency room of the hospital immediately and take the package of the medicine with you. If you forgot to take the medicine:

If you forgot to take a dose of Clopidogrel Teva but remembered within 12 hours of the usual dosing time, take a tablet immediately, and take the next tablet at the usual time. If you forgot to take a tablet and more than 12 hours have elapsed since the usual dosing time, just take the next single dose at the usual time. Do not take a double dose in order to compensate for the forgotten dose. Follow the treatment as recommended by the doctor.

If you stop taking Clopidogrel Teva: If you stop taking Cloploggrel leva:
Do not stop taking the medicine unless
the doctor has instructed you to do so.
Refer to your doctor or pharmacist
before discontinuing the treatment.
Do not take medicines in the dark! Check
the label and the dose every time you
take the medicine. Wear glasses if you
need them.

If you have any other questions regarding use of the medicine, consult your doctor or pharmacist.

4. Side effects

4. Side effects
As with any medicine, using Clopidogrel
Teva may cause side effects in some users.
Do not be alarmed when reading the list
of side effects. You may not experience any of them

Consult with the doctor immediately if

the following signs appear:
Fever, signs of infection or extreme fatigue. These may indicate a rare decrease in certain types of blood cells. Signs of a liver problem, such as

yellowing of the skin and/or eyes (jaundice), whether or not associated with subcutaneous bleeding appearing as pinpoint red dots, and/or confusion (see section 2 "Before using the medicine", under "Special warnings regarding the use of the medicine").

Swelling of the mouth or skin problems such as real, itching and skin blisters.

such as rash, itching and skin blisters. These may be the signs of an allergic

reaction.

The most common side effect reported with this medicine is bleeding. The bleeding may occur as bleeding in the stomach or intestines, as a bruise, as a hematoma (unusual bleeding or bruising under the skin), as a nose bleed, or as bleed in the urine in a small number of blood in the urine. In a small number of cases bleeding has also been reported in the eye, inside the head, in the lungs

or in the joints.

If you suffer from prolonged bleeding during treatment with the medicine:

If you injure or cut yourself, it may take longer than usual for the bleeding to stop. This effect is related to the mechanism of action of the medicine, because it prevents the formation of blood clots. In cases of mild cuts or injuries, such as cutting yourself cuts or injuries, such as cutting yourseir while shaving, there is usually no problem. However, if you are concerned about the bleeding, refer to your doctor immediately (see section 2 "Before using the medicine", under "Special warnings regarding the use of the medicine").

Common side effects (can affect up to 1 in 10 users):

Diarrhea, abdominal pain, dyspepsia or heartburn.

Uncommon side effects (can affect up

to 1 in 100 users):
Headache, stomach ulcer, vomiting, nausea, constipation, excessive gas in the stomach or intestines, rash, itching, dizziness, sensation of tingling or numbness.
Rare side effects (can affect up to 1 in 1000 users):

Rare side effects (can affect up to 1 in 1,000 users):
Vertigo, breast enlargement in men.
Very rare side effects (can affect up to 1 in 10,000 users):
Jaundice, severe abdominal pain with or without backache, fever, breathing difficulties sometimes associated with coughing; general allergic reactions (such as overall sensation of heat with sudden general discomfort, which may even as overall sensation of heat with sudden general discomfort, which may even lead to fainting), swelling of the mouth, skin blisters, skin allergy, inflammation of the oral mucosa, drop in blood pressure, confusion, hallucinations, arthralgia (joint pain), myalgia (muscle pain), altered sense of taste or loss of the taste of food.

Side effects of unknown frequency (their frequency cannot be estimated from the existing data):

Hypersensitivity reactions accompanied by chest or abdominal pain, symptoms of continuously low blood sugar level. In addition, the doctor may notice changes in your blood or urine tests.

- 5. How to store the medicine?
  Avoid poisoning! This medicine and any other medicine must be kept in a closed place out of the reach and sight of children and/or infants to avoid
- poisoning.
  Do not induce vomiting without an explicit instruction from the doctor.
- not use the medicine after the expiry date (exp. date) appearing on the package. The expiry date refers to the last day of that month.
  Store in a dry place under 25°C.
  Do not use the medicine if you observe visible changes in the tablet.
  Bottle package: after first opening of the bottle, the medicine can be used up to the expiry date.

Do not flush medicines down the drain or throw them in your domestic trash. Ask your pharmacist how to dispose of medicines you no longer use. These measures will help protect the environment.
