#### 10.4 Concomitant Administration with Other Live Vaccines

Concomitant administration of the trivalent formulation of FluMist Quadrivalent—with Measles, Mumps, and Rubella Virus Vaccine Live (MMR, manufactured by Merck & Co., Inc.)—orand the Varicella Virus Vaccine Live (manufactured by Merck & Co., Inc.) has not been studied. Concomitant administration of FluMist with MMR and the varicella vaccine—was studied in children 12 through 15 months of age [see Clinical Studies (15.5)]. Concomitant administration of FluMist with—the MMR and the varicella vaccine with the trivalent or quadrivalent formulations has not been studied in children older than 15 months of age has not been studied.

Each of the reassortant strains in FluMist Quadrivalent express the HA and NA of wild-type viruses that are related to strains expected to circulate during the <a href="https://www.example.com/2021-2022-2023">2023</a> influenza season. Three of the viruses (A/H1N1, A/H3N2 and one B strain) have been recommended for inclusion in the annual trivalent and quadrivalent influenza vaccine formulations. An additional B strain has been recommended by the USPHS for inclusion in the quadrivalent influenza vaccine formulation.
