

Ibuprofen - belongs to a group of medicines known as

non-steroidal anti-inflammatory drugs (NSAIDs). These medicines provide relief by reducing pain, swelling and high temperature. Pseudoephedrine - belongs to a group of drugs called vasoconstrictors which act on the blood vessels in the nose to relieve nasal congestion

Nurofen Cold and Flu is intended for use in children older than 12 years and works in the following ways: Clears a blocked nose and sinuses

- Relieves pains, headache and high temperature
- Eases the discomfort of a sore throat

Pregnancy, breastfeeding and fertility: Pregnancy: This medicine has a possible side effect of renal injury in the fetus and low levels of amniotic fluid as of the 20th week of pregnancy.

Avoid as much as possible using Nurofen Cold and Flu during the first 6 months of pregnancy. Do not use this medicine if you are in the last 3 months of pregnancy Breastfeeding: Do not use this medicine if you are breastfeeding. Fertility: Nurofen Cold and Flu belongs to a group of medicines that may

impair fertility in women. This condition is reversible on stopping use of the medicine. It is unlikely that occasional use of this medicine will affect the chance of becoming pregnant. However, if you are having difficulty becoming pregnant, consult a doctor before using the medicine. Important information about some of the ingredients of the medicine:

about the dosage and manner of treatment with the product. The usual recommended dosage is: Adults and children of 12 years and older: 1 tablet every 4-6 hours, as

long as the symptoms persist. If there is no response and there is no improvement in the pain or fever upon taking one tablet, 2 tablets can be taken. Do not take more than 6 tablets in 24 hours. Take the lowest dose and for the shortest period of time necessary to relieve the symptoms.

If you have an infection, consult the doctor without delay if the symptoms (such as fever and pain) do not improve or worsen (see section 2). Do not administer this medicine to children under 12 years of age.

Do not take the medicine for longer than 10 days unless your doctor If symptoms persist or pain or fever worsen, or if any new symptoms occur, consult your doctor or pharmacist.

Swallow the medicine with water.

Duration of treatment:

There is no information regarding crushing/halving/chewing. If you have taken an overdose or if a child has accidently

swallowed the medicine, always refer to a doctor or nearest hospital in order to get an opinion regarding the risk and to consult about the action to be taken. If you have accidently taken a higher dosage the following symptoms may develop: nausea, abdominal pain, vomiting (may be blood

streaked), headache, ringing in the ears, confusion and nystagmus. At high doses, drowsiness, chest pain, palpitations, loss of consciousness, convulsions (mainly in children), weakness and dizziness, blood in urine, cold body sensation, and breathing problems have been reported.

If you forget to take the medicine take according to the instructions of use written above, do not take more than recommended

Do not take medicines in the dark! Check the label and the dose each time you take the medicine. Wear glasses if you need them. If you have further questions regarding the use of the medicine,

attention immediately in case of: · Signs indicating intestinal bleeding such as:

- Bright red stools, black tarry stools, vomiting blood or dark particles that look like coffee grounds

Signs indicating serious allergic reaction such as:

- Breathing difficulties - Dizziness or faster heartbeat

Severe forms of skin reactions such as itchiness, skin rash with redness, peeling, flaking or blistering (such as Stevens-Johnson syndrome) Swelling of the face, tongue or throat

Signs of aseptic meningitis with neck stiffness, headache, nausea, vomiting, fever or loss of consciousness. Patients with autoimmune disorders (lupus, mixed connective tissue disease) have a higher chance to be affected

A severe skin reaction known as DRESS syndrome (Drug

Reaction with Eosinophilia and Systemic Symptoms). Symptoms of DRESS include: skin rash, fever, swelling of lymph nodes and an increase in the number of eosinophils (a type of white blood cells). · Sudden onset of fever, reddening of the skin, or many small

pustules (possible symptoms of Acute Generalized Exanthematous Pustulosis - AGEP) that may occur within the first two days of treatment with Nurofen Cold and Flu. · Red rash with scales, widespread, and with bumps under the skin and

blisters located primarily on the skin folds, center of the body and upper limbs, which is accompanied by fever at the beginning of the treatment (acute generalized exanthematous pustulosis). See section 2. Inflammation of the colon due to insufficient blood supply

Stop using the medicine and tell your doctor if you experience the following uncommon side effects: Indigestion, heartburn or nausea.

· Pains in upper abdomen or other abnormal abdominal problems.

Tell your doctor if you suffer from any of the following side effects. if they become worse or if you notice any effects not mentioned: Uncommon side effects:

- Allergic reactions, such as skin rashes (urticaria), itching, peeling of the skin

- Flatulence (wind), diarrhoea, constipation and vomiting

· Very rare side effects: - Blood disorder leading to unexplained or unusual bleeding, fever,

5. How to store the medicine?

Avoid poisoning! This medicine, and any other medicine, must be stored in a closed place out of the reach and sight of children and/or infants, to avoid poisoning. Do not induce vomiting unless explicitly instructed to do so by the doctor.

Do not use the medicine after the expiry date (exp. date) stated on the package. The expiry date refers to the last day of that

Storage conditions: Store below 25°C. In any case of doubt, consult the pharmacist who dispensed you the

medicine. Do not store different medicines in the same package.
