1. What the medicine is used for ?

Antifungal treatment.

2. Before using the medicine

X Do not use the medicine:

- If you are sensitive (allergic) to the active substance or to any of the additional ingredients contained in the medicine. For the list of the inactive substances - see Section 6 "Additional information".
- If you suffer from diabetes.

ⓘ Special warnings concerning use of the medicine:

- Do not use on large skin area.
- Do not use on wounded skin, vitiligo, birthmarks and hairy warts.
- If you are breast-feeding, or if you are suffering from vascular dysfunction or diabetes, consult your doctor before using the medicine.

• Avoid contact with the eyes and mucous membranes. In case of such contact, rinse thoroughly with water.

• Do not light a cigarette or expose yourself to an open flame until the preparation is fully dried.

ⓘ If you are taking, or recently took, other medicines, including over the counter medicines and dietary supplements, inform your doctor or pharmacist.

ⓘ Pregnancy and breast-feeding:

If you are in the first/last trimester of pregnancy or if you are breast-feeding, consult your doctor or pharmacist before using the medicine.

Important information about some of the ingredients of the medicine:

Contains alcohol, flammable substance.

3. How to use the medicine?

Ask your doctor or pharmacist if you are not sure.

Manner of use:

Apply to the wounded skin with cotton wool imbibed with the medicine, 1-3 times a day and leave until the site is dry.

Do not exceed the recommended dosage.

Do not swallow. For external use only.

If you have taken an overdose or if a child has accidentally swallowed the medicine, go immediately to a doctor or a hospital emergency room and bring the medicine package with you.

Do not take medicines in the dark!

Check the label and the dose each time you take your medicine.

Wear glasses if you need them.

If you have further questions concerning use of the medicine refer to your doctor or pharmacist.

4. Side Effects:

As for any medicine, the use of Spirit Whitfield may cause side effects in some users.

Do not be alarmed by the list of side effects. You will probably not suffer from any of them.

Stop treatment and refer to your doctor:

• In case of inflammation or local irritation (rare).

Other Side Effects: Rash.

If one of the side effects becomes more serious, or you suffer from a side effect not mentioned in the insert, consult your doctor. 5. How to store the medicine?

• Avoid poisoning!

This medicine, and all other medicine, must be stored in a safe place out of the reach of children and/or infants, in order to avoid poisoning.

Do not induce vomiting unless explicitly instructed to do so by the doctor.

• Do not use the medicine after the expiry date appearing on the package.

The expiry date refers to the last day of that month.

• Store in a cool place, below 25°C.

• Close tightly.

• Warning! Flammable substance, keep away from fire.

• Store in the original package.

• You can use the product after opening until expiry of its validity.
