 The medicine is intended for treatment

- of chronic asthma, including prevention of symptoms during the day and night, treatment of asthma patients who are sensitive to aspirin, and to prevent narrowing of the airways induced by physical exertion in adults and adolescents over 15 years of age. The medicine is intended to relieve symptoms of seasonal allergic rhinitis in The
- adults and adolescents over 15 years of age. Therapeutic group: Montelukast is a selective antagonist of the leukotriene receptor. In other words,

montelukast works by blocking receptors to leukotriene in the airways. Leukotrienes are chemical substances that cause narrowing and swelling of the airways. Leukotrienes also cause allergy symptoms. What is asthma? Asthma is a chronic lung disease; it cannot be

# cured, it can only be controlled.

Asthma typically includes: Narrowed airways which make it difficult to breathe. This narrowing of airways worsens

- conditions. • Inflammation of the airways, which means swelling in the lining of the airways. • Sensitive airways that react to many things,
- such as cigarette smoke, pollen, or cold air. Symptoms of asthma include:
- coughing, wheezing, and chest tightness. Not all people who have asthma have wheezing.

In some people the only symptom of asthma will be a cough. Symptoms usually appear during the night or after exercise. What is exercise-triggered asthma? Asthma triggered by exercise, more accurately known as exercise-induced bronchoconstriction

What is seasonal allergic rhinitis? Seasonal allergic rhinitis (also known as hay fever) is triggered by external allergens such as airborne pollen from trees, grass, and weeds.

- In rare cases, patients taking Montelukast experience a combination of several symptoms that do not pass or even get worse. These symptoms may include: flu-like illness rash tingling feeling like pins and needles or numbness in the arms or legs
- difficulty breathing • acute inflammation (pain and swelling) in the sinuses (sinusitis) These symptoms usually, but not always
  - occurred in patients taking oral corticosteroid tablets to treat their asthma, when the dosage of the steroid medicines was slowly lowered or stopped. Although it has not been proved that montelukast causes these

symptoms, tell your doctor immediately if you experience any of the symptoms listed above.

 Behavior and mood related changes have been reported in patients taking montelukast. If you experience such changes while you are taking Montelukast Teva 10 mg (see section 4: 'Side effects') tell your doctor. Montelukast Teva 10 mg contains lactose. If your doctor has told you that you have an intolerance to certain sugars, consult your doctor before taking this medicine.

# 3. HOW SHOULD YOU USE THE MEDICINE?

Always use the medicine according to the doctor's instructions. Check with your doctor or pharmacist if you are not sure about your dose or about how to take this medicine.

The dosage and treatment regimen will be determined by the doctor only. The usual dosage is: Adults and adolescents above 15 years of

age to treat asthma and/or seasonal allergic rhinitis: One 10 mg tablet, once a day.

Do not exceed the recommended dosage. Take Montelukast Teva 10 mg once a day with or without food, as instructed by your

To treat seasonal allergic rhinitis,

instructed by your doctor.

Make sure that your inhalers for use during an acute attack of asthma are always within reach. Do not take an additional dose of Montelukast Teva 10 mg within 24 hours from the previous dose.

## How to take Montelukast Teva 10 mg: Do not chew! Swallow the tablet with some

water, regardless of meals. Do not halve the tablet (there is no score line).

If you take more Montelukast Teva 10 mg

than you should accidentally took an overdose, or if a

child accidentally swallowed some medicine, go to a hospital emergency room immediately and bring the medicine package with you. Do not induce vomiting without an explicit instruction from the doctor!

If you forget to take Montelukast Teva 10 mg

If you forgot to take the medicine at the required time, do not take the missed dose when you remember it. Resume the usual schedule for taking the medicine instructed by your doctor. Do not take a double dose to make up for the forgotten dose. How can you contribute to the success of your treatment?

# Adhere to the treatment as recommended by

the doctor. Even if there is an improvement in your health

or you experience an asthma attack, do not stop treatment or change the times you take it without consulting your doctor. As far as possible, avoid contact with triggers that can start an asthma attack such as smoking, dust mite, mold, pollen, animals,

changes in weather, exposure to cold air. you have asthma and aspirin makes ur asthma symptoms worse, continue your asthma symptoms worse, continue avoiding aspirin or other medicines known as nonsteroidal anti-inflammatory drugs

(NSAIDs) while you are taking Montelukast Teva 10 mg. Do not take medicines in the dark! Check the label and dose <u>every time</u> you take the medicine. Wear glasses if you need them.

# while using Montelukast Teva 10 mg: Behavior and mood related changes [agitation including aggressive behavior or hostility,

- depression, disorientation (confusion), attention disorders, bad or vivid dreams, feeling anxious, hallucinations (seeing or hearing things that are not there), insomnia, irritability, impaired memory, restlessness, sleep-walking, suicidal thoughts and actions (including suicide), tremor]. in certain blood white Increase (eosinophils), inflammation of blood vessels
- throughout the body (multiple organ vasculitis) is possible. Symptoms of these conditions may include: flu-like illness, rash, tingling feeling like pins and needles or numbness in the arms or legs, severe inflammation (pain and swelling) in the sinuses (sinusitis). These symptoms may rarely occur in people with asthma who take Montelukast Teva 10 mg or in people who are also taking oral steroids, when the dosage of the steroid medicines is slowly lowered or
