Clobetasol Propionate-Trima Scalp Solution

Clobetasol propionate 0.05% w/w

Each 1 gram contains 0.5 mg clobetasol propionate (0.05% w/w)

The list of additional ingredients is detailed in section 6.

Read the leaflet carefully in its entirety before using the medicine.

This leaflet contains concise information about the medicine. If you have further questions, refer to the physician or pharmacist

This medicine has been prescribed for you. Do not pass it on to others. It may harm them even if it seems to you that their medical condition is similar.

The medicine is not intended for children under 1 year of age

1. WHAT IS THE MEDICINE INTENDED FOR?

Clobetasol Propionate-Trima Scalp Solution is used to treat inflammatory conditions responsive only to corticosteroids.

It contains a medicine called clobetasol propionate and belongs to a group of medicines called steroids.

Therapeutic group: Corticosteroids

2. BEFORE USING THE MEDICINE

Do not use the medicine:

- if you are sensitive (allergic) to clobetasol propionate or to any of the additional ingredients contained in the medicine, as listed in section 6.
- if you have a skin infection on the scalp.
- in children under 1 vear of age.

Do not use if any of the above apply to you. If you are not sure, talk to your physician or pharmacist before using Clobetasol Propionate-Trima Scalp Solution.

Special warnings regarding use of the medicine

Before treatment with Clobetasol Propionate-Trima Scalp Solution, tell the physician:

- if you have previously had an allergic reaction to another steroid.
- if you are applying the solution under an airtight dressing. These types of dressings make the absorption of the active ingredient through the skin easier and it is therefore possible to accidentally end up using too high dosage of the

Do not bandage or otherwise cover the treated scalp area, unless you received an explicit instruction from the physician.

- if you received instruction to cover the treated area with a dressing, make sure that the skin is clean before applying a fresh dressing, to avoid infections.
- if you have psoriasis, your physician will want to see you more often.
- if you are applying the solution on broken, damaged or thin skin.
- if you are applying the solution to a large skin area.

Contact your physician if you experience blurred vision or other visual disturbances If an infection develops while using the medicine, consult the physician or

Be very careful not to get the solution come into contact with your eyes. If you are not sure if any of the above apply to you, talk to your physician or pharmacist before using this medicine.

Children

- Do not use this medicine in children under 1 year of age.
- Avoid extended use in children over the age of 1 year, as their skin is thinner than that of adults and, as a result, can absorb a larger amount of the solution.
- Use in children must be limited to a few days and be accompanied by a weekly
- In children, do not use dressings and patches on the site where the scalp solution is applied.

Additional warnings

 Contains inflammable substance: do not light a cigarette or come into contact with fire until the preparation has completely dried

If you are taking, have recently taken or might take other medicines, including non-prescription medicines and nutritional supplements, tell the physician or pharmacist. Especially if you are taking ritonavir or itraconazole medications.

Pregnancy, breastfeeding, and fertility

If you are pregnant or breastfeeding, or think you may be pregnant or if you are planning to become pregnant, consult your pharmacist or physician before taking

3. HOW SHOULD YOU USE THE MEDICINE?

Always use according to the physician's instructions.

Check with the physician or pharmacist if you are not sure.

The dosage and treatment regimen will be determined by the physician only. The recommended dosage is usually:

- Application of Clobetasol Propionate-Trima Scalp Solution on your scalp in the morning and at night. The dosage may be reduced when your scalp problem begins to improve, or will be discontinued when the problem improves. For use on the skin of your scalp only.
- Do not use Clobetasol Propionate-Trima Scalp Solution more often than prescribed for you or use it for a prolonged period (e.g., every day for many weeks or months)

If you need prolonged treatment, your physician can decide that you need a milder treatment The bacteria that cause infection thrive in warm and moist conditions that exist

under dressings

If you were instructed to cover the treated area with a dressing, always clean the skin before applying a clean dressing to prevent infection of the skin under

- Be very careful not to let the solution get into your eyes. Do not touch your eyes until you have washed your hands.
- If you wash or shampoo your hair, it needs to dry before applying the solution.
- If you are applying Clobetasol Propionate-Trima Scalp Solution on someone else, make sure you wash your hands after use, or wear disposable plastic
- Caution! Contains inflammable substance. Avoid exposure of the solution to an open fire, to flames and to any other ignition source, including smoking, when applying the solution or immediately after applying the solution
- Do not dry your hair with a hairdryer.

Instructions for applying the solution:

- Wash your hands.
- 2. Open the bottle cap and place the nozzle directly on the scalp that needs treating
- 3. Gently squeeze the bottle to cover the area with a thin and even layer of solution.
- 4. You can rub the solution in, but you do not have to.
- 5. Your scalp will feel cool until the solution has dried.
- 6. Wash your hands again.

Do not exceed the recommended dose.

Do not swallow.

For external use only.

- Use in children
- Do not use this medicine in children under 1 year of age
- In children, it is extremely important not to exceed the prescribed amount.
- The duration of treatment for a child should not usually last more than a few days, unless your physician has told you to use the solution for longer. The physician may want to see the child every week during the course of treatment with Clobetasol Propionate-Trima Scalp Solution.

If you accidentally took a higher dosage

If you applied too much, or if you accidentally swallowed the scalp solution, you may get sick. Refer to your physician or proceed to a hospital as soon as possible. If a child accidentally took the medicine, immediately refer to a physician or proceed to a hospital emergency room and bring the package of the medicine with vou.

If you forgot to take the medicine

If you forgot to apply the solution on the scalp, apply it as soon as you remember. If it is almost time for the next time you planned to apply it, wait until that time Do not apply more Clobetasol Propionate-Trima Scalp Solution to compensate for the missed dose

Adhere to the treatment regimen as recommended by the physician. Even if there is an improvement in your health, do not discontinue treatment with the medicine without consulting with the physician.

If you stop taking the medicine

If you use Clobetasol Propionate-Trima Scalp Solution regularly, be sure to consult your physician before you stop using it, since your condition may worsen if the treatment is stopped abruptly. Do not take medicines in the dark! Check the label and the dose each time you

take the medicine. Wear glasses if you need them. If you have further questions regarding use of the medicine, consult the physician

4. SIDE EFFECTS

As with any medicine, use of Clobetasol Propionate-Trima Scalp Solution may cause side effects in some users. Do not be alarmed by the list of side effects, you may not suffer from any of them.

Stop using Clobetasol Propionate-Trima Scalp Solution and refer to the physician immediately if:

- vou discover that your scalp problem is getting worse, you develop a generalized rash, or your skin becomes swollen during treatment. You may be allergic to Clobetasol Propionate-Trima scalp Solution, have an
- infection, or need other treatment. • you have psoriasis and develop bumps with pus under the skin. This can happen during or after the treatment and is known as pustular psoriasis.

Additional side effects you may notice when using Clobetasol Propionate-Trima Scalp Solution include:

Common side effects (may occur in up to 1 in 10 people)

• a feeling of burning, pain, irritation or itching in the area where the solution is

Uncommon side effects (may occur in up to 1 in 100 people)

- skin thinning, which may cause stretch marks.
- blood vessels under the surface of your skin may become more noticeable.

Very rare side effects (may occur in up to 1 in 10,000 people)

Use of Clobetasol Propionate-Trima Scalp Solution for a long period of time, or use under an airtight dressing, may cause the following symptoms:

- increased weight
- . moon face, rounding of the face
- obesity
- skin thinning
- skin wrinkling
- skin drvness
- changes to the color of the skin
- increased amount of body hair
- hair loss/lack of hair growth/damaged looking hair

Other very rare skin side effects that may occur:

- allergic reaction at the site of application
- · worsening of skin condition · application site irritation or pain
- redness
- · rash or hives
- if you have psoriasis, you may get raised bumps with pus under the skin. This can happen very rarely during or after treatment and is known as pustular psoriasis.
- skin infection

In children, pay attention to the following signs:

- slowed weight gain
- slowed growth

Very rare side effects that may show up in blood tests results or when your physician gives you a medical examinations:

- a decrease in the level of the hormone cortisol in your blood
- increased level of sugar in the blood or urine
- · high blood pressure
- cloudy lenses in the eyes (cataract) increased pressure in the eve (glaucoma)
- weakening of the bones through gradual loss of minerals (osteoporosis)
- Additional tests may be needed after the medical examination to diagnose this condition.

5. HOW SHOULD THE MEDICINE BE STORED?

- · Avoid poisoning! This medicine, and any other medicine, should be kept in a closed place out of the sight and reach of children and/or infants in order to avoid poisoning. Do not induce vomiting unless explicitly instructed to do so by the physician
- Do not use the medicine after the expiry date (exp. date) that appears on the package. The expiry date refers to the last day of that month.
- Store below 25°C.

- Keep the bottle tightly closed when not in use.
- The contents are inflammable. Keep away from any source of fire, flames or heat. Do not leave exposed to direct sunlight.
