3. HOW SHOULD YOU USE THE MEDICINE?

The usual dosage is generally:
Glycerin and Glycerin Forte Suppositories:
One suppository a day, as needed.
This medicine is not usually intended for children and infants under 6 years of age.
Glycerin Pediatric Suppositories: One suppository a day for children, as needed.
Do not use in children under 2 years of age without a doctor's instruction.

Do not exceed the recommended dose. In continuous use of over a week, consult the doctor.

Do not swallow. This medicine is intended for rectal use only.

Directions for Use:

- First, wash your hands well
- First, wash your hands well.
 Remove the wrapper from the suppository. The suppository can be moistened with a little water to ease insertion.
 Lie down on your side. Push the suppository as deep as possible into the rectum with your finger. If the suppository is too soft to insert, cool it in the refrigerator for 30 minutes or run a stream of cold water over it before removing it from its wrapper.
 Wash your hands after inserting the suppository.

The preparation usually takes between 15-60 minutes to act.

If you accidentally took a higher dosage If you took an overdose, or if a child has accidentally swallowed the medicine, refer immediately to a doctor or proceed to a hospital emergency room, and bring the package of the medicine with you. Do not induce vomiting unless explicitly instructed to do so by the doctor!

- the treatment? It is advisable for the suppository to remain in the rectum for approximately 15 minutes. The treatment should be accompanied by appropriate consumption of fluids (1-1.5 liters), dietary habits (fiber-rich diet) and
