Active ingredients: Each lozenge contains:

2,4-Dichlorobenzyl alcohol 1.2 mg Amylmetacresol 0.6 mg

Inactive ingredients: Please see section 6 Additional information.

Read this entire leaflet carefully before you start taking this medicine. This leaflet contains concise information about the medicine. If you have any further questions, ask your doctor or pharmacist. This medicine can be sold without a doctor's prescription. This medicine is intended for adults and children over 6 years of age. Under this age refer to your doctor. Use the medicine in the correct manner. Consult your pharmacist if you need additional information. Refer to your doctor if the symptoms of your illness worsen or do not improve within 3 days.

1. What is the medicine used for? Antiseptic medicine for the relief of sore throat in children and adults.

Therapeutic group

Both active ingredients are antiseptics (disinfectants). Sucking the lozenge allows the active ingredients to work in the painful area and lubricate and soothe the painful area.

2. Before you take the medicine

Do not use the medicine if:

- you are hypersensitive (allergic) to the active ingredients or to any of the other ingredients of this medicine (detailed in section 6).
- This medicine is not intended for children and infants under the age of 6 years.
- vou suffer from intolerance to certain sugars such as fructose, from malabsorption of glucose-galactose and deficiency of the enzyme sucraseisomaltase. This information should usually be confirmed with your doctor.

Special warnings regarding the use of this medicine:

· Refer to your doctor if you suffer or have suffered in the past from additional throat problems.

Please tell your doctor or pharmacist if you are taking or have recently taken any other medicines, including

non-prescription drugs and nutrition supplements.

Pregnancy and breastfeeding:

It is not recommended to use this medicine if you think you are pregnant, if you are pregnant or while breastfeeding. If you are pregnant or breastfeeding consult your doctor before using any medicine.

Important information about some of the ingredients of this medicine

This medicine contains sucrose and glucose. If you have been told by your doctor that you suffer from intolerance to certain sugars, consult your doctor before using this medicine.

3. How to use this medicine

Check with your doctor or pharmacist if you are not sure.

This medicine must be dissolved in the mouth. Do not chew or break the lozenge. Suck the lozenge slowly, one lozenge every 2-3 hours, up to a maximum of 12 lozenges in 24 hours

This medicine is not intended for children under 6 years of age. Remember that young children are at risk of choking on lozenges.

Refer to your doctor if your condition does not improve within 3 days or if an unusual change occurs in your condition. Do not exceed the recommended dose.

If you have accidentally taken an overdose

- You might suffer from abdominal pain.
- Stop using this medicine and consult your doctor

Do not take medicines in the dark! Check the label and dose each time you take your medicine. Wear glasses if you need them.

If you have any further questions regarding the use of this medicine, consult your doctor or pharmacist.

4. Side effects

Like all medicines, the use of Strepsils Ginger can cause side effects, although not everybody gets them.

Side effects which appear uncommonly:

- HypersensitivitySkin rash.

Stop the use of this medicine and consult your doctor.

If any of the side effects worsens, or if you experience side effects not mentioned in this leaflet, consult your doctor.

5. How to store the medicine

· Avoid poisoning! This medicine, and all other medicines, must be stored in a safe place out of the reach of children and/or infants, to avoid poisoning. Do not induce vomiting unless explicitly instructed to do

so by your doctor.

- Do not use the medicine after the expiry date (exp. date) stated on the package/carton/label. The expiry date
- refers to the last day of that month.

 <u>Storage conditions</u>: store at a temperature below than 25°C. Store in the original package.

6. Additional information

- · In addition to the active ingredients, this medicine also contains: Tartaric acid, Anthocyanins (E163), Fruity plum flavour, Soothing cream flavour, Warm sensation flavour, Warm ginger spice flavour, Medium chain triglycerides, Liquid sucrose (1384 mg/lozenge), Liquid glucose (1102 mg/lozenge).
