This medicine is intended to treat infections caused by bacteria sensitive to Amoxycillin.

Therapeutic group: Semi-synthetic penicillin-group antibiotics.

During prolonged treatment, you should undergo periodic kidney, liver, and blood function tests. While taking this medicine, you must inform your doctor before taking tests to measure glucose levels in the blood or urine, because treatment with this medicine may cause false positive

Before treatment with Amoxi Care Forte 250 Suspension, tell your doctor if: You are pregnant or breastfeeding. You are suffering, or have suffered in the past, from impaired function of: The kidneys. The dinective and

- The digestive system (e.g. enteritis).
 The blood system (e.g. coagulation, etc.).
 If you are currently being treated for a kidney problem.
 If you are not passing water regularly.
 If you have suffered in the past from an allergic reaction to any type of an inhibitior.

 Probenecid or Allopurinol (for gout).

Birth control pills – Amoxycillin may decrease the effectiveness of the pills, and it is therefore recommended to use an additional method of contraception, such as a condom or a diaphragm with

a spermicide, during this treatment.

Oral anticoagulants, such as warfarin.

Use of this medicine and food: Amoxi Care Forte 250 Suspension may be taken with or without food.

Pregnancy and breastfeeding: Consult a doctor if you are pregnant or breastfeeding.

Driving and the use of machinery: This medicine is not expected to affect your ability to drive or to operate machinery.

3. How should this medicine be used?

This medicine mustalways be used according to doctor's instructions only. Check with the doctor or pharmacist if you are unsure. Suspension preparation instructions: For the 60 ml packaging: The pharmacist will add 41 ml distilled water to the bottle and shake well until homogenous suspension

is obtained

For the 100 ml packaging: The pharmacist will add 70 ml distilled water to the bottle and shake well until homogenous suspension

Is outained.

The dosage and the method of treatment will be determined by the doctor only.

The attending physician will determine the required dosage and length of treatment with this medicine in accordance with the type and severity of infection from which you suffer

and severity of infection from which you suffer.

Do not exceed the recommended dosage.

Directions for use: Shake the bottle well before each use.

Make sure to measure the dose of the suspension using the enclosed measuring cup. This medicine may be taken with or

enclosed measuring cap. This income may, without food.

If you have accidentally taken an overdose, or if a child has accidentally swallowed the medicine, refer immediately to your doctor or to a hospital emergency room and bring the medicine

If you forget to take this medicine at the required time, take the next dose as soon as you remember and continue the normal dosage schedule, but never take two doses at the same time in order to make up for a missed dose. 4. Side effects

4. Side effects
As with any medicine, the use of Amoxi Care Forte 250 Suspension may cause side effects in some users. Do not be alarmed by the list of side effects. You may not experience any of them.

Stop the treatment and refer to your doctor immediately in the following concern.

- Stop the treatment and rever to you.

 In the following cases:

 Extremely rare side effects (Side effects with an incidence of less than 1 in 10,000 patients):

 A severe allergic reaction which includes a rash or itching, swelling of the face, lips, tongue, or body, difficulty breathing. This side effect is severe and in some cases has even led to death.

 An allergic reaction which causes inflammation of the blood vessels and includes symptoms of a rash or red spots under the skin, or signs of bruising. This reaction may be accompanied by

blisters, redness, and pain, occasionally accompanied by rever, headache and body aches.

Fever, chills, sore throat and other signs of inflammation, easily caused bruises. These may indicate a problem with the blood cells. Inflammation of the large intestine accompanied by diarrhea, at times with blood in the stools, pain and fever.

Serious side effects related to the liver that usually occur in cases of prolonged treatment with the medicine, in men or in the elderly. These side effects are usually reversible. Consult your doctor immediately in the following cases:

Severe diarrhea with bleeding.

Dark urine or pale stools.
 Yellowing of the skin or eyes (jaundice). (This symptom may also occur as a sign of anemia. See below.)
These side effects may occur during the treatment or several weeks after the end of the treatment.
