Carefully read the package leaflet before using this medicine. This leaflet contains concise information on the medicine. If you have additional questions, contact your doctor or pharmacist.

This medicine is given without a prescription.

The medicine is intended for adults, children and adolescents.

You must use it correctly. Consult your pharmacist if you need more information.

You must contact a doctor if symptoms worsen or do not improve.

## 1.What is the medicine for?

Skin disinfection solution

This medicine is a disinfectants substance - Antibacterial Cleansing Agent.

### 2. Before using this medication

Do not use if:

If there is known sensitivity to the medicine.

Special warnings regarding the use of this medicine:

Keep away from eyes. If you are sensitive to any food or medicine, inform your doctor before using this medication. The preparation contains more than 20% alcohol. **Do not light a cigarette and avoid exposure to fire until the solution is completely dry.** 

# 3. How to use this medicine?

According to need, you should check with your doctor or pharmacist if you are unsure.

#### How to use:

Dosage:

Wash your hands thoroughly, soak the liquid medicine with a clean cotton wool and clean the area for disinfection. Do not swallow, for external use only.

#### 4. Side Effects

Like any medicine, use of the medicine may cause side effects in some users.

If you experience a side effect while using this medicine, inform your doctor.

# 5. How to store your medicine?

Avoid poisoning! This medicine and other medicines must be kept out of reach of children and/ or infants, to avoid poisoning. Do not induce vomiting without a direct order from a doctor.

If accidentally you have swallowed the medicine, go to the emergency room of a hospital, and bring the medicine with you. Do not use after the expiration date (exp. date) shown on the packaging/ bottle/ label. Expiry date refers to the last day of that month.

Store below 25°C.

Can be used for up to 6 months after the bottle is first opened, and no later than the expiry date that appears on the package.

Danger! Flammable material, keep away from fire.

### 6. More information
